

## **CEBS Virtual Exam Code of Conduct**

I certify, attest, pledge, swear and affirm, under penalty of perjury, by taking a CEBS virtual exam, that:

- I will abide by the provisions of the rules of the CEBS Virtual Exam Code of Conduct accompanying this exam.
- I am the named person scheduled to take the exam.
- I understand that if I have requested Continuing Education Credit for this exam for any license or designation, that it is my responsibility to determine if a virtual non-proctored exam is acceptable or if an actual proctor is required to be present. If an actual proctor is required, it is also my responsibility to make those arrangements before proceeding with this exam. If my state/province requires validation of a proctor with an affidavit, I will submit that affidavit verifying this information to the CEBS program at <a href="Continuinged@ifebp.org">Continuinged@ifebp.org</a> within 24 hours of taking this exam. I also understand that I will not receive CE credit if I do not submit a required affidavit.
- I will complete the exam without assistance from any other persons and will not communicate with anyone during the exam.
- I will take the examination in a space that is private and clear of all extraneous materials such as study notes, course materials, programmable calculators, erasable whiteboards and all mobile devices including cell phones, handheld computers and additional computer monitors.
- I understand that I am subject to The Certified Employee Benefit Specialist (CEBS) Precertification Standards of Personal and Professional Conduct; and I understand and accept that CEBS, through its exam administrators, conduct ongoing data forensics to identify response patterns to examination questions and may invalidate any testing results that indicate testing irregularity.
- I understand that this is a timed exam and once the exam starts, the timer continues to run and cannot be paused.
- I understand that all results are final, numerical scores are not released, and grading is on a Pass/Non-Pass basis.
- I understand and accept that test questions and responses will not be returned under any conditions.
- I will not make copies of any exam questions and will not post any exam questions anywhere including any internet and/or social media sites. I understand that, in
